- I. Meeting called to order at 7:04 pm

- **III.** Announcements
 - a. Gary Winemiller stated that Ed Snyder's cancer has gotten worse as it's a fast growing cancer. Please keep him in your thoughts and prayers as he goes through this.
 - b. Kevin Byrne stated that Pete O'Brien has been in the hospital with pancreas issues. He seems to be doing better but is still a bit under the weather.
 - c. Bill Bryce has gotten a card for Ed Snyder and it will be passed around for everyone to sign.

IV. Reports

- a. Secretary
 - i. Previous Annual Membership meeting minutes reviewed. Kevin Byrne moved to approve as written, Gary Winemiller seconded. Approved unanimously.
 - ii. Previous Annual Membership Meeting Minutes can be found on the website for review.
- b. Treasurer
 - i. Tom Clappi presented the Treasurer's report.
 - ii. See attached Treasurer's Report for full details on the band's finances.
 - iii. The BB&T account was closed last year and all funds have been deposited into a new Wells Fargo account. This new account has been working wonderfully for the band.

- iv. Gary Winemiller asked if the proper task forms have been completed for the band. Tom Clappi stated that they have and since we are under \$25,000 in total funds, it's a simple post card we have to fill out.
- c. President
 - i. Jim Kraftchak read the written president's report provided by Mike Lacey since he had surgery earlier in the day and was unable to make the meeting.
 - ii. A copy of the report can be found in the attachments of these minutes.
- d. Vice President
 - i. Matt Lopez presented his report as Vice President.
 - ii. A copy of the report can be found in the attachments of these minutes.
- e. Member-At-Large
 - i. Jim Ryan presented the Member-At-Large report.
 - ii. The Member-at-Large position did not have a clear definition when the year started. That has changed as will be shown in the Bylaw updates. The position now is the liaison between the band members and the Board of Directors.
 - iii. The band has gotten stronger over the year thanks to the hard work of everyone.
 - iv. Recruitment remains a big issue for the band and especially drummers so please look to find anyone who might be interested in joining.
- f. Drum Major
 - i. Bill Bryce stated that what everyone had said to this point is correct and that recruiting is a must. We need younger players to keep the band going.
 - ii. Keep doing what we are doing as we are doing great.
- g. Pipe Major
 - i. Steve Boulton stated that we have made great strides in the musicality of the band. We are play much better at this point than we were last year.
 - ii. An inventory of chanters is being maintained so that we know who has what and that we can have spare chanters for when we need them.
 - iii. Steve Boulton stated that after two years of being the Pipe Major he is stepping down. He will remain with the band just not in the role of Pipe Major.
 - iv. Many thanks for his service as P/M were given by all in attendance.
- h. Quartermaster
 - i. A copy of the inventory report can be found in the attachments of these minutes.

- ii. Two kilts were purchased last year (Ryan and Dispenza) and that was the biggest expense.
- iii. We may need a few more kilts in the coming year depending on when folks get on the street.
- iv. Jim Martin stated that he needed a new belt as the one he has is too large.
- v. Phil Nannery suggested that we maintain a complete uniform set for Jim Ryan so that if he is missing anything at an event we have it available for him.
- i. Uniform Officer
 - i. Gary Winemiller stated that Uniform Manual was updated last year to reflect the changes in the uniform and is available on the website. Everyone needs to download it and review and make sure your uniform meets the requirements.
 - ii. There will be an uniform inspection in April 2020, exact date to be announced, where all uniform items will be inspected and anything that needs to be replaced will be replaced if possible.
 - iii. Overall appearance over the last year was pretty good. We do need uniformity in pipe bags and cords however. Cords and bags should be green and seeing red and purple and other colors when we are performing looks wrong.
 - iv. If the changes to the bylaws pass at this meeting then if someone wants to make a change to the uniform, it should be put into writing and submitted to Gary Winemiller who will review it and pass it along to the board along with his recommendations.
- j. Band Manager
 - i. Lisa Heilbraun thanked everyone that made all the gigs that the band did this past year. We know it takes a lot of time to perform at these gigs from your personal life.
 - ii. Please use TeamSnap early and often. All events are put up there as soon as we have the information and this information is critical in determining if the band will perform at an event or not.
 - iii. Steve Boulton stated the Piper Major and Drum Major use TeamSnap to determine how to set up the band based on how many folks are signed up and the level of experience with those folks.
 - iv. Matt Lopez suggested that we use TeamSnap to track rehearsals so that we know who will be attending and even potentially what the plan for the rehearsal is in regards to music and times on pipes, etc...
 - v. Lisa Heilbraun stated that if you find that a gig is not that good and do not want to do it again to let her know.
- V. New Business
 - a. Chieftains Concert

- i. The concert will be held on Thursday March 19, 2020.
- ii. Steve Boulton stated that auditions will be required for the music in order to perform at the concert.
- iii. Bill Bryce stated that this is at least a half day event if not all day. Plan to arrive no later than 2PM and be there for duration.
- iv. Bill Bryce also stated that everyone should start planning for the St. Patrick's Day week as we'll have the Pub Crawl on St. Patrick's day, rehearsal and then the Chieftains concert.
- b. St. Patrick's Day Pub Crawl Fundraiser
 - i. Phil Nannery is the committee chair for this event and is currently lining up venues for us to play at.
 - ii. We will be starting at Patriots Bar and Grill around 3PM and then get on a bus and begin the tour.
 - iii. Since we will have done Manassas the weekend before with the parade, we will not be doing any pubs there for this event.
 - iv. Band will charge \$300 to each pub and then pass the boot for playing 2 sets over a 30 to 45 minute period before moving on to a new pub.
 - v. PJ Skidoos, Jimmy's Old Towne Tavern and Patriots Bar and Grill are just a few pubs that have signed on at this point. If you have a favorite pub, please let Phil know ASAP so he can contact them. We plan to stay in the Fairfax, Reston, Herdon, Sterling area in order to move easily about from place to place.
 - vi. Bus with a bathroom will cost around \$1,000 \$1,200 and one without and is smaller would be around \$760-\$900.
 - vii. Even with the bus expense taken out, we can make between \$3,000-\$5,000.
 - viii. Jim Ryan stated that if we do 5 different bars he would be surprised to see us clear \$4,000 by evenings end.
 - ix. Lisa stated that we should go with the bus with the bathroom that way we have more room, can sell seats on the bus and don't have to worry about having a bathroom.
 - x. Phil Nannery motioned that we get the larger bus with the bathroom and Steve Boulton seconded. Motion passed unanimously.
- c. Bylaw Updates
 - i. Matt Lopez introduced they updates to the bylaws and stated that the committee that worked on these put in a lot of time and effort to ensure that were as good as possible.
 - ii. Jason Allen motioned that we vote on the bylaws as a block rather than individually. Tom Clappi seconded and the motion passed unanimously.
 - iii. Steve Boulton motioned that the bylaws be read as a review prior to any discussion or voting. Matt Bickert seconded and motion passed unanimously.

- iv. Matt Lopez read the summary of the bylaws updates document, which is included as an attachment to this document.
- v. Bill Bryce asked if a business meeting is the Annual Membership Meeting. Matt Lopez responded that no it is referring the board of directors meeting as the business meeting.
- vi. John Bideganeta asked with section 4.1 why the requirement for the P/M and D/M to have fire service. Matt Lopez responded that it is one or the other needs to have it since we are a fire service band.
- vii. Upon completion of the reading of the changes a call was made to pass the bylaw changes as read. 19 Yeas, 2 Nays. Bylaws changes have been passed.
- viii. Matt Lopez again thanked everyone who worked so hard on getting these bylaw updated put together.
- d. Elections
 - i. Pipe Major
 - 1. Because the bylaw changes have passed, the Pipe Major is now elected by the general membership instead of being appointed by the board.
 - 2. Steve Boulton nominated Jason Allen and Bill Bryce seconded.
 - 3. No other nominations were made. Congratulations Jason Allen on becoming the new Pipe Major.
 - ii. Drum Major
 - 1. Because the bylaw changes have passed, the Drum Major is now elected by the general membership instead of being appointed by the board.
 - 2. Kevin Byrne nominated Bill Bryce and Phil Nannery seconded.
 - 3. No other nominations were made. Congratulations Bill Bryce on retaining the Drum Major.
 - iii. Board of Directors
 - 1. Matt Lopez turned the elections over the Gary Winemiller to run
 - 2. Jason Allen stated the Mike Lacey has decided that he will not run for any position due to work and personal reasons.
 - 3. President
 - a. Tom Clappi nominated Phil Nannery who declined.
 - b. Jason Allen nominated Matt Lopez and Brian Dunn seconded.
 - c. No other nominations were made
 - d. Count was Matt Lopez 12 and Bill Bryce 7.

- e. Matt Lopez is the new president, congratulations.
- 4. Vice President
 - a. Steve Boulton nominated Bill Bryce and Jason Allen seconded.
 - b. Tom Clappi nominated Jim Martin who declined.
 - c. Jason Allen nominated Steve Boulton and Matt Bickert seconded.
 - d. Count was Bill Bryce 12 and Steve Boulton 6.
 - e. Bill Bryce is the new vice president, congratulations.
- 5. Secretary
 - a. Jason Allen nominated Jim Kraftchak and Lisa Heilbraun seconded.
 - b. No other nominations
 - c. Jim Kraftchak unanimously elected as secretary, congratulations.
- 6. Treasurer
 - a. Jason Allen nominated Tom Clappi and Matt Lopez seconded.
 - b. No other nominations
 - c. Tom Clappi unanimously elected as treasurer, congratulations.
- 7. Member-At-Large
 - a. Jason Allen nominated John Bideganeta who declined.
 - b. Jason Allen nominated Beth Morgan who declined.
 - c. Gary Winemiller nominated Jim Ryan and Tom Clappi seconded.
 - d. Matt Bickert nominated Steve Boulton and Brian Dunn seconded.
 - e. Count was Jim Ryan 16, Steve Boulton 2.
 - f. Jim Ryan is the Member-At-Large, congratulations.
- 8. Gary Winemiller closed nominations.
- VI. Good of the Order
 - a. Jason Allen asked Gary Winemiller what Ed Snyder needs. Gary stated that he will let us know as things progress with Ed.
 - b. Bill Bryce asked if Ed would like any visitors. Gary stated that the best thing right now is to call and chat with him. Gary also stated that depending on where he is being treated, he might need assistance getting to and from his appointments but that is yet to be determined and Gary will let us know when he knows anything.
 - c. Kevin Byrne stated that Pete O'Brien is doing better right now but we'll see how things go with him.

- d. Jim Ryan mentioned that the MacMillan Pipe Band is doing a concert in Blackrock Arts Center on February 8. Tickets are around \$40 and it would be good for us to attend since it won't be all pipes and a number of the MacMillan Pipe Band members came to our fundraiser in April and supported us so we should go and support them.



November 20, 2019

The purpose of this document is provide a summary of all the proposed changes to the Bylaws in one simple complete location. The affected paragraph of the bylaws will be listed and then under that will show the original language and the proposed change that will be voted on at our Annual Membership Meeting in January.

a. 2.1.1

- i. Original: Membership is open to all adults at least 19 years old, ...
- ii. Proposed Change: Membership is open to all adults at least 18 years old,

b. 2.1.3

- i. Recommended addition of the following language to the end of the paragraph: Additional duties for students including carry banner, fundraising, supporting events.
- ii. Jim Ryan motioned that we change the proposed language to: Additional duties for students may include carrying banner, fundraising, and supporting events as required. Matt Lopez seconded and the motion passed unanimously.
- iii. Sentence will be added to the end of the paragraph
- c. 2.1.6
 - i. Original: Other: Children of full members, age 16 to 19 may participate with the band student members or in such other capacity as determined by the Pipe Major / Drum Major.
 - Proposed Change: Other: Children of members (as defined in section 2.1.1) under the age of 18, may participate with the band as student members or in such other capacity as determined by the Pipe Major / Drum Major &/or President. Mike Lacey seconded and motion passed unanimously.
- d. 2.1.7
 - i. Proposed change to add paragraph 2.1.7 which would read: Accompaniment: Band members below the age of 18, when the band is performing in a venue where alcohol is available, he/she must be accompanied by parent, guardian or designated temporary guardian.

- e. 2.4
- i. Original: **Voting**: All Members in Good Standing have the privilege of voting on various issues related to band activities.
- ii. Proposed Change: **Voting**: All Members in Good Standing have the privilege of voting on various issues related to band matters at general or special membership meetings.
- f. 2.5
- i. Original: **Responsibilities**: All members are responsible to maintain a commitment to support the band at practices and performances.
- ii. Proposed Change: **Responsibilities**: All members are responsible to maintain a commitment to support the band at active participation at rehearsal, scheduled and unscheduled events.
- g. 2.7
- i. Original: A quorum for the purpose of managing the business of the band shall be designated as 65% of the members in good standing.
- ii. Proposed Change: A quorum for the purpose of managing the business of the band shall be designated as 2/3 of the members in good standing.
- h. 2.8
- i. Original: **Business Meeting**: A business meeting shall be held quarterly.
- ii. Proposed Change: **Business Meeting**: A business meeting shall be held quarterly, or more often as the board requires.
- i. 3.1
- i. Original: **Committees**: Members appointed to committees by the Board of Directors shall perform such duties as may be determined by the Board of Directors, for example fundraising.
- ii. Proposed Change: **Committees**: Members appointed to committees by the Board of Directors shall perform such duties as may be determined by the Board of Directors, for example fundraising, recruitment, uniform, by-laws, etc.
- j. 3.6.1
 - i. Original: CFO: The Treasurer shall be the chief financial officer of the Corporation and shall have custody of corporate fund and accounts. The Treasurer shall disburse funds of the Corporation as ordered by the Board of Directors or the President taking proper voucher for such disbursements. He/she shall render to the President and the Board of Directors at the regular meetings of the Board of Directors, or whenever the directors my request it, an account of his/her transactions as Treasurer and of the financial condition of the Corporation.
 - ii. Proposed Change: The Treasurer shall pay in a timely fashion at his or her sole discretion any reasonable expenses submitted by product or service providers, not to exceed \$200. Such disbursements must be presented to the Board of Directors at the subsequent Board of Directors meeting for ex-post facto approval. Any expenses greater than \$200 must be approved by a majority of the Board of Directors prior to payment.
- k. 3.6.2

- i. Original: Filing: The Treasurer shall also maintain and distribute copies of the band rosters and shall be responsible for filing all annual tax returns and corporate forms, as necessary.
- ii. Proposed Change: Filing: The Treasurer shall be responsible for filing all annual tax returns and corporate forms, as necessary.
- l. 3.6.3
 - i. Original: He/she shall also maintain a computer disk with all band financial transactions for the current year.
 - ii. Proposed Change: He/she shall also maintain a electronic and back-up files with all band financial transactions for the current year.
- m. 3.7.1
 - i. Original: He/she shall record all proceedings of the meetings of the Corporation and its directors and shall cause a copy of that record to be inserted in a book to be kept for that purpose, and shall perform such other duties as may be assigned to him/her by the directors or the president.
 - ii. Proposed Change: He/she shall record all proceedings of the meetings of the Corporation and its directors and shall cause a copy of that record to be electronically stored and saved, and shall perform such other duties as may be assigned to him/her by the directors or the president.
- n. 3.7.3
 - i. Proposed change to add the following to the end of the paragraph: He/she shall maintain and publish copies of the band roster.
- o. 3.8 Member at Large
 - i. Proposed change to insert paragraph 3.8 Member At Large which will read: Unlike other executive board leadership such as a president or treasurer, a member at large doesn't have a specific role. A member at large serves as a liaison to the general membership. Duties change as needed to fulfill board requirements and address overall organizational goals.
- p. Due to inserting paragraph 3.8 Member At Large, current paragraphs 3.8 through 3.10 will be renumbered to 3.9 through 3.11
- q. 3.9
- i. Original: Unexpected vacancies in the Board of Directors shall be replaced in an election by the general membership at the next scheduled business meeting or, in the event of an urgent need, in an electronically conducted vote.
- ii. Proposed Change: Unexpected vacancies in the Board of Directors shall be replaced in an election by the general membership at the next scheduled business meeting or, at a special membership meeting.
- iii. Additionally this paragraph will be renumbered to 3.10
- r. 3.10
 - i. Original: **Ex Officio Members:** Certain Band Officers, such as the Pipe Major and Drum Major, or Administrative Officers, such as Quartermaster or Band Manager, if not elected to a Corporate Officer or At Large position

on the Board, shall be an Ex Officio Officer of the Board with seat and voice but not vote.

- ii. Proposed Change: **Ex Officio Members:** Certain Band Officers, such as the Pipe Major and Drum Major, or Administrative Officers, such as Quartermaster, Web Master or Band Manager, if not elected to a Corporate Officer or At Large position on the Board, shall be an Ex Officio Officer of the Board with seat and voice but not vote.
- s. Article IV
 - i. Original: The Pipe Major and Drum Major shall be elected by the Board of Directors and shall serve a two-year term.
