- I. Meeting called to order at 6:57 pm
- II. Members in Attendance: Matt Lopez, Bill Bryce, Tom Clappi, Matt Bickert, Lisa Heilbraun
  - a. Not in attendance: Jim Kraftchak, Jason Allen.

## III. Reports

- a. Secretary: Motion to approve Clappi, 2<sup>nd</sup> Bickert. Approved unanimously.
- b. Treasurer:
  - i. Current bank account \$9,012.41.
  - ii. Money still coming in from NFFF, should go up by \$1K. There was an extra \$62 fee for last minute cancellation by Bickert at NFFF.
  - iii. Several donations including Retirement Associ, \$120 and \$600 for parades.
  - iv. \$174 spent for FTD, \$2098 for hotel in NFFF, \$400.68 for Dinner at Gettysburg Eddies board dinner.
  - v. Re-occurring fee of \$105 for storage.
- c. Ouartermaster:
  - i. Dispensa's uniform needs to be re-obtained.
